CONGRATULATIONS BROOKE, RILEY AND HAYLEY


We received several excellent applications for the Montana Electric Cooperatives' Association Memorial Scholarship, which was awarded by



FERGUS ELECTRIC PREPARES FOR 85TH ANNUAL MEETING

VEN though our June 8th annual meeting is still more than a month away, I wanted to focus on this unique event for our message. Electric cooperatives are structured in a way that members can actively participate in decisions that direct our vision, mission and values during the annual meeting. Active member participation helps us understand items of concern or importance to our members. We have many members that join us every year at the trade center. I appreciate their time and dedication to attend. We enjoy seeing and visiting with you. With that, we would really enjoy seeing our total attendance numbers increase.

Unfortunately, a growing trend throughout the United States is the decline in member attendance at cooperative annual meetings. I recently reviewed historic documents from Fergus Electric's annual meetings in the 1940s & 1950s. More members attended our annual meetings back then than we had in 2022. I would encourage you to mark June 8th on the calendars and attend our upcoming meeting at the Fergus County Trade Center. Registration will begin at 11:00

a.m., lunch will be served at noon, and our business meeting will start at 1:00 p.m.

We will be presenting information on proactive line inspection and maintenance, infrastructure replacement and investment, rate structures and eventual rate increases. We review financial information to show that our cooperative continues to grow in membership and electric revenues, while maintaining expenses at reasonable levels. We will share how we actively participate in our state's legislative session and that we have a strong relationship with the elected officials who represent us at the federal level. Our long-term wholesale power supplier, Basin Electric Power Cooperative, continues to help us lower our wholesale power costs, which has helped postpone the need for a rate increase.

The impressive team at Fergus Electric is engineering and constructing electric lines to ensure that we continue to provide reliable electric service at a reasonable and affordable cost to our members. Our plans include invest-


