## MANAGER'S MESSAGE

#### From Carson Sweeney

#### A discussed at our June 8<sup>th</sup>, 2023 annual meeting, Fergus Electric Cooperative, Inc. (Fergus) recently completed a cost-of-service analysis to review our existing rate structure as compared to our monthly business expenses.

Fergus has been able to sustain 12 years without a rate increase, and we do not expect a rate increase in 2023. Fergus continues to maintain strong margins with consistent capital credit retirements, and investments in our equipment and infrastructure. To better align monthly wholesale power expenses to our monthly revenues, we are modifying the rate structure we offer to our members, effective January 1, 2024.

#### **Revenue Neutral**

Our intention to implement a revenue-neutral rate structure change is occurring at a time when Fergus' finances are stable and there is no need for a rate increase. Our team has reviewed our rate restructuring plan in a diligent and serious manner. We understand that these decisions will impact our membership for many years to come.

#### **Three-Part Rate Structure**

The new rate structure will include a monthly base charge, a lower energy charge (kilowatt hour), and a peak demand charge (killowatt). The rate changes will be revenue neutral to Fergus Electric yet may increase or decrease your monthly bill based on your usage profile. Our goal for fair and reasonable rates is a top priority. Many electric cooperative utilities in Montana have successfully implemented three-part rate structures such as this. Strategic and intentional changes like this will help a strong electric cooperative maintain fair and stable rates long into the future.

#### Peak Demand (kW) Hours

Our team is thoroughly reviewing historic metering data to identify specific hours of the day for when our entire electrical system hits peak load. Once this information is reviewed by our Board of Directors, we will be able to communicate which hours of the day we will be assessing the peak demand kW charge. We are hoping to narrow this window down to just a handful of hours each day to give our members the best opportunity to help normalize the peak and reduce their monthly costs.

#### Additional Information

I hope that through proactive and transparent communications such as this, Fergus will continue to uphold the trust that we have established throughout our member-owned cooperative to provide reliable, safe and affordable energy services to the members we serve. We will provide additional information on our rate structure change in upcoming issues of the *Rural Montana* magazine.
